**FIRST AMENDMENT TO AGREEMENT
between the
DOUGLAS COUNTY HEALTH DEPARTMENT
and
UNIVERSITY OF NEBRASKA-LINCOLN EXTENSION OFFICE**


This Agreement entered into on July 15, 2015 between Douglas County, Nebraska, on behalf of the Douglas County Health Department ("Department"), and University of Nebraska-Lincoln Extension Office ("Contractor"), for the purpose of increasing access to locally grown produce to residents in Douglas County, Nebraska is hereby amended, effective July 20, 2016, as set forth here:

Section II, Subsection A of the Agreement is hereby amended to delete the following clause:

- A. Duration. This Agreement shall become effective on May 1, 2015 and shall remain in effect until September 15, 2016. This Agreement may be terminated upon mutual written consent of the parties or by either of the parties giving ninety (90) days written notice to the other of its intention to terminate the Agreement.


And replaces it with the following clause:

- A. Duration. This Agreement shall become effective on May 1, 2015 and shall remain in effect until October 31, 2016. This Agreement may be terminated upon mutual written consent of the parties or by either of the parties giving thirty (30) days written notice to the other of its intention to terminate the Agreement.
