**BOARD OF COUNTY COMMISSIONERS**  
**DOUGLAS COUNTY, NEBRASKA**

**WHEREAS**, pursuant to Neb. Rev. Stat. §23-1204, the County Attorney, may, with the approval and consent of the County Board, appoint one or more deputies, who shall receive such compensation as shall be fixed by the County Board to assist him in the discharge of his duties; and,

**WHEREAS**, the Douglas County Attorney requests that this Board authorize new salaries for two supervisory Deputy County Attorneys as follows:

Theresia Urich (Civil Division Supervisor): \$124,000 (currently is paid \$102,037)

Nicole Brundo (Juvenile Division Supervisor): \$128,000 (currently is paid \$107,072);  
and,

**WHEREAS**, these salaries represent increases to their current salaries, and shall become effective with the first pay period after January 1, 2016; and,

**WHEREAS**, the Douglas County Attorney requests that the County Board allocate sufficient funds to his budget to fund these new salaries.

**NOW, THEREFORE, BE IT RESOLVED BY THIS BOARD OF COUNTY COMMISSIONERS, DOUGLAS COUNTY, NEBRASKA**, that this Board hereby authorizes the above-referenced salaries for Theresia Urich and Nicole Brundo, to be effective with the first pay period after January 1, 2016, and this Board hereby directs that sufficient funds be allocated to the County Attorneys budget to fund these increases.
