**RESTORATIVE PRACTICES TRAINING SERVICES AGREEMENT**

**WITH**

**CONCORD MEDIATION CENTER**

**FIRST AMENDMENT**

This Agreement was entered into by and between Concord Mediation Center (hereinafter Contractor), a Nebraska organization with its principal place of business at 4225 North 90<sup>th</sup> Street, Omaha, NE 68134, and Douglas County, Nebraska (hereinafter County), a political subdivision of the State of Nebraska, with its principal place of business at 1819 Farnam Street, Ste. LC2, Omaha, NE 68183.

The Agreement between the parties dated January 12, 2016 is hereby amended as follows:

1. Section 6 is amended to read:

**5. Term and Termination.** The Agreement will begin January 12, 2016 and end September 30, 2016, or upon expenditure of the allotted Grant Funds, whichever occurs earlier, with an option to renew for one (1) additional three (3) month extension upon mutual written agreement of both parties. Either party may terminate the Agreement upon thirty (30) days written notice to the other party. Any Contractor breach of these provisions or failure to satisfactorily perform, as determined by County, shall be cause for automatic termination.

2. All other original terms and conditions shall remain in full force and effect.
